# MINOR PARTICIPATION AGREEMENT

I represent that I am the parent or legal guardian of the minor participant identified below (hereafter "my child"). By signing this release, I hereby warrant that I have the legal right, without limitation, to enroll my child into the On The Edge Summer Discipleship program (hereafter "On the Edge"), hosted by Calvary Chapel of Costa Mesa on June 23rd 2018 - July 28th 2018 at the Murrieta Hot Springs Christian Conference Center, 39405 Murrieta Hot Springs Rd., Murrieta, CA 92563. By placing my signature below, I hereby grant my permission to allow my child to attend and participate in the On the Edge classes and/or sessions without restriction or limitation.

I understand and agree with the "On The Edge" Doctrinal Statement and principles, which include the belief that students, including my child, who attend public school are being taught about sex from a non-Christian worldview at a very early age and that if children are not learning this information at school, they are learning this information from their friends and associates, many of which do not have a Biblical perspective on these issues. It is my desire as a parent to join with On The Edge in educating our youth, including my child, with a solid understanding about what the Bible teaches about purity, sex, marriage, dating, and other related topics including but not limited to topics such as sexuality, gender identity issues, homosexuality, pornography, etc., as well as any other related questions which may arise from students in attendance to which On The Edge staff, speakers, or teachers may respond in order provide students with guidance on these issues.

In consideration of Calvary Chapel of Costa Mesa's agreement to permit my child to participate in On The Edge, the receipt and sufficiency of which consideration is hereby acknowledged, I, individually, and on behalf of my child and our respective heirs, successors, assigns and personal representatives, agree as follows:

## **(I) General Liability Release and Indemnification**

I understand that there are certain risks, known and unknown, including property damage, bodily injury and death, which could result from my child's travel to, from, and participation in On The Edge. I nonetheless authorize my child to participate in On The Edge and I agree that my child assumes any and all risks of injury or harm, of any kind, that may be sustained by my child while traveling to, from, or participating in On The Edge. To the fullest extent permitted by law, I fully release and discharge Calvary Chapel of Costa Mesa, its representatives, affiliates, subsidiaries, divisions, members, directors, officers, employees, agents, servants, volunteers, On The Edge staff, On The Edge speakers, On The Edge teachers, owners of the property and property management of Murrieta Hot Springs Christian Conference Center, or any of them (collectively referred to herein as "Calvary Chapel"), from all actions, suits, claims, causes of action, and demands for any injury or harm of any kind whatsoever which may arise from or out of my child's travel to, from, or participation in On The Edge, however such injury or harm is caused, even if it is caused in whole or in part by action, inaction, or negligence of Calvary Chapel. This release is intended to discharge Calvary Chapel against any and all liability arising out of or connected in any way with my child's travel to, from, or participation in the On The Edge, even though that liability may arise out of the negligence or carelessness on the part of Calvary Chapel.





Should any claim be made or any lawsuit be filed against Calvary Chapel on account of any injury or damage to my child arising from any or related in any way to my child's travel to, from, or participation in On The Edge, I agree to defend, save, hold harmless, and to fully and completely indemnify Calvary Chapel for any and all amounts incurred, whether by settlement or judgment, including any amounts incurred by Calvary Chapel in defending against any such claim or judgment, including all attorney's fees and costs incurred. Moreover, should any claim be made or any lawsuit be filed against On The Edge by any third party on account of the acts or conduct of my child arising from any or related in any way related to my child's travel to, from, or participation in On The Edge, I further agree to defend, save, hold harmless, and to fully and completely indemnify Calvary Chapel from any and all amounts incurred, whether by settlement or judgment, as well as any amounts incurred by Calvary Chapel for defending against any such claim or judgment, including all attorney's fees and costs incurred.

This general liability release and indemnity agreement shall apply to all known, unknown and/or unanticipated injuries and damages resulting from or during my child's travel to, from, or participation in On The Edge from any cause whatsoever. I EXPRESSLY WAIVE THE PROVISIONS OF SECTION 1542 OF THE CIVIL CODE OF THE STATE OF CALIFORNIA AND ANY SIMILAR PROVISIONS OF THE LAWS OF ANY OTHER JURISDICTION, WHICH READS AS FOLLOWS:

"A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor."

## **(II) Authorization for Third Party Consent to Medical Treatment**

I give my informed consent to allow Calvary Chapel and any First Aid personnel assigned by Calvary Chapel, to provide basic First Aid and comfort measures to my child through standardized treatment procedures which includes the use of over-the-counter medications. I authorize HCF to provide my child with the following generic, over-the-counter medications as directed by the labels provided by the manufacturer: analgesics, decongestants, antihistamines, cough suppressant and/or expectorants, throat lozenges or spray, anti-nausea/diarrhea, antacid, antibiotic ointment, hydrocortisone cream, burn cream, petroleum jelly, chapped skin/lip treatment, antiseptic skin and wound cleansers, ipecac, glucose, laxatives, electrolyte replacement fluids, analgesic balms and gels, with the exception of \_\_\_\_\_

I authorize Calvary Chapel to arrange for or provide any necessary transportation for my child to the nearest medical facility for urgent or emergency medical treatment, if indicated, and I assume all responsibility for payment for such treatment. I acknowledge that my child has his or her own medical and dental insurance and I fully and unconditionally release and indemnify Calvary Chapel from all liability for any medical or dental treatment rendered to my child. I hereby authorize and consent for my child to receive any x-ray, examination, anesthetic, medical or surgical diagnosis rendered under the general or special supervision of any member of the medical staff and emergency room staff licensed under the provisions of the Medicine Practice Act or a dentist licensed under the provisions of the Dental Practice Act and on the staff of any acute general hospital holding a current license to operate a hospital from the State of California Department of Public Health.



I understand that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required, but is given to provide authority and power to render care to my child to which the aforementioned medical and dental professionals in the exercise of their best judgment may deem advisable. I understand that every effort shall be made to contact me prior to rendering any treatment to my child, but that any of the above treatment will not be withheld if I cannot be reached. This authorization is given pursuant to the California Family Code section 6910, and similar provisions of the laws of the State or Country in which the medical or dental care is being sought.

I hereby authorize any hospital, medical facility, other medical or dental provider who has provided treatment to my child to surrender physical custody of my child to Calvary Chapel upon the completion of treatment. This authorization is given pursuant to Section 1283 of the Health and Safety Code of California, and similar provisions of the laws of the State or Country in which the medical or dental care is being provided.

These authorizations shall remain effective through the dates set forth above for the On the Edge Summer Program, unless sooner revoked in writing.

**(III) Video/Photo Release**

During On the Edge, photographs may be taken and videos may be produced and used for future publicity. I give permission for photographic images and video's of my child captured during On The Edge, to be used for the purposes of Calvary Chapel, including in promotional materials and publications and I waive any rights of compensation or ownership thereto.

**(IV) Other Acknowledgements**

I understand and acknowledge that On the Edge is intended to provide encouragement, guidance and teaching for those with a genuine desire to grow in their walk and seek the Lord's direction for their life. I further understand and acknowledge that my child is required to recognize the leadership and oversight of the On The Edge pastoral team, as well as to abide by all On The Edge Rules & Guidelines. I understand that, should my child fail to support these intentions, fail to follow the On The Edge Rules & Guidelines, or fail to follow instructions of the Conference Center and Bible College Staff, Calvary Chapel reserves the right to remove my child from On The Edge.

No oral representatives, statements, or inducements have been made by or between the parties to this Agreement with respect to the subject matter of this Agreement apart from the matters set forth within this Agreement.

**In signing this Agreement, I hereby acknowledge and represent that I have read this entire document, that I understand its terms and provisions, that I understand it affects my legal rights and those of my child, that it is a binding Agreement, and that I have signed it knowingly and voluntarily.**

**God.** We believe that there is one living and true God, who exists in three persons as the Father, Son, and Holy Spirit. All equal in power and authority, the Godhead is the Creator, sustainer, and governor of all things.

**Bible.** We believe that God has communicated to us through the Old and New Testaments, which are true and without error. Scripture is the foundation of our individual lives and the blueprint for His church.

**Creation.** We believe that God created our world and gave it life. He is the Maker, who by simply speaking brought everything into existence and tasked humanity to care for it.

# TEAM COVENANT

THE FOLLOWING TEAM COVENANT IS AN AGREEMENT BETWEEN EACH TEAM MEMBER, ONE TO ANOTHER, AND THE OTE LEADERS.

**PURPOSE STATEMENT:** The purpose of On the Edge is to bring young men and women into a deeper relationship with Jesus Christ. To best facilitate this goal, we ask our students to follow the heart set by the On the Edge team covenant.

**FLEXIBILITY:** 1 Corinthians 9:9 states, "for though I am free from all men, I have made myself a slave to all, that I might win the more." We agree as a team to be flexible in our attitudes, actions, and circumstances as we allow Christ's purposes to be carried out through us. "To the weak I am weak; I have become all things to all men, that I may by all means save some." 1 Corinthians 9:22.

**ACCOUNTABILITY:** Philippians 2:3 states, "do nothing from selfishness or empty conceit, but with humility of mind let each of you regard one another as more important than himself." In all our actions during this program, we are individually accountable to God first of all. We agree to be accountable to the counselors, supervisors, and other members of our team. We also agree to encourage each other to be faithful servants of God. Hebrews 10:24 states, "but encourage one another day after day, as long as it is still called 'today' lest any one of you be hardened by the deceitfulness of sin."

**RESPONSIBILITY:** Philippians 2:4 states, "Do not merely look out for your personal interests, but also for the interests of others." As team members, we pledge to carry out our tasks in a responsible and timely manner. We will handle all ministry equipment and assignments as tools and gifts in which God has entrusted to us. "And whatever you do, do it heartily, as to the Lord, and not unto men." Colossians 3:23.

**TIME / PUNCTUALITY:** Philippians 2:3 states, "Do nothing from selfishness or empty conceit, but with humility of mind let each of you regard one another as more important than himself." We agree to exhibit respect to team members and others by arriving on time and carrying out tasks on time. If a situation arises which causes one to be late, we agree to inform leaders and team members right away. We agree that time is given to us for God to accomplish His purposes and being punctual is an outward display of using God-given time wisely.

**CULTURE:** As a team, we realize that we are entering other cultures as guests. We will, to the best of our ability, refrain from passing judgment on customs that are foreign to us because they are simply different. We realize that we answer first and foremost to God, therefore we will refrain from any activities that violate God's Word. As a team, we will strive to show respect to those who are native to the country we are ministering by learning their customs and culture as well as living as they do. We hope that we may gain credibility as people with a genuine love for them as we labor to present the news of Christ to them.

**ALCOHOL AND TOBACCO:** Corinthians 9:22 states, "I have become all things to all men so that by all possible means I might save some." In order to express the best image for Christ as possible, and in light of the alcohol-related problems so rampant in many countries, we will abstain from drinking alcoholic beverages, using narcotics and tobacco (cigaretts, vape, marijuana, ect.)

**TRAVEL:** Before planning any trips outside of our pre-scheduled group itinerary, we will discuss it with the team leader, nor will we travel anywhere without another team member. We agree to stay together in a group wherever we may go, unless given permission to be apart from the group.

**CONFLICT RESOLUTION:** As a team, we agree that when we have conflicts and differences among ourselves, we will, first through prayer and time in the Word, examine ourselves for selfish motives and unrealistic expectations of the other person. We will take responsibility to approach or confront the other person if it is appropriate. We will do this in love, for the purpose of restoring unity. We will forgive one another and pray together. We will not discuss the matter with other members of the team, causing them to become involved in the conflict. "In your anger, do not sin. Do not let the sun go down while you are still angry, and do not give the devil a foothold." Ephesians 4:26-27. If a conflict cannot be settled among the two parties, they will then seek counsel from the group leader.



**TEAM UNITY:** We agree that being united as a team means that as in Philippians 2:1-2, we must be “like minded, having the same love, being one in spirit and purpose.” We will accomplish this as outlined in Philippians 2:3-8: We will do nothing out of selfish ambition or vain conceit, but in humility, consider others better than ourselves. We will look not only to our own interests, but also to the interest of others. We realize that each team member is vital and has something unique to contribute; he or she should be encouraged and given opportunity to develop and utilize his/her spiritual gifts. Romans 12:4-6 states, “For just as we have many members in one body and all the members do not have the same function, so we, who are many are one body in Christ, and individually members one of another. And since we have gifts that differ, according to the grace given to us, let each exercise them accordingly.”

**GOSSIP:** As a team we agree to speak only words to and about each other that will serve to build up and encourage. We will refrain from remarks that would hurt or tear down. “With the tongue we will praise our Lord and Father, and with it we curse men, who have been made in God’s likeness. Out of the same mouth come praise and cursing. My brothers, this should not be. Can both fresh water and salt water flow from the same spring?” James 3:9-11.

**EMERGENCY OR CONTINGENCY PLAN:** If an emergency or crisis develops, the team will follow the following principles:

1. Whatever action is taken, the **TEAM STAYS TOGETHER**. There is no room for individual action. If a team member is away from the group at the time of the event, he or she must immediately return to the group and contact the group leader.
2. Once the team leader is contacted, he will assess the situation and make further contingency plans. If necessary, he will contact a supervisor from On The Edge, who will be a communication link to our families.
3. A decision to leave an area will be made in conjunction with the team leader, the On The Edge supervisor and national leaders in country. The team leader or team members will not seek to make a decision without consultation with local national leaders. They know the situation best and know the best way to leave the area.
